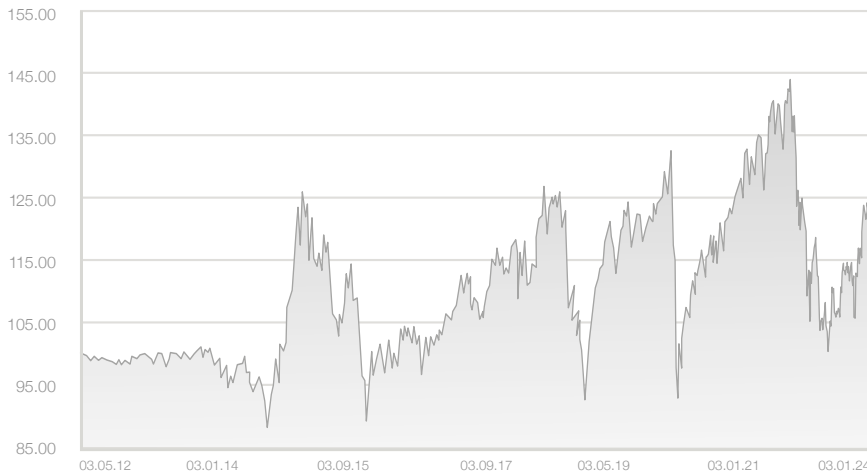

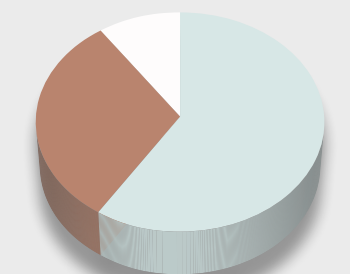

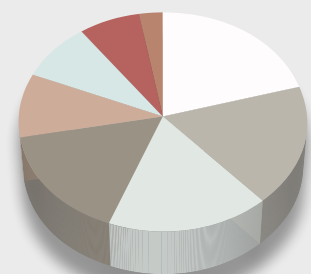
Geographic & Trend Distribution
