#### 1. Redemption

Where a completed Redemption Notice is submitted by facsimile or email the original must be immediately forwarded to the Administrator by post.

I/We being the registered holder/s of Shares in Opportunities Plus Fund (the "Fund") hereby apply to have the number of Shares/Currency amount indicated above redeemed subject to the terms of the current Offering Memorandum and the Articles of Incorporation of the Fund.

Subject to the terms of the Offering Memorandum, the minimum shareholding in the Fund is USD10,000.
