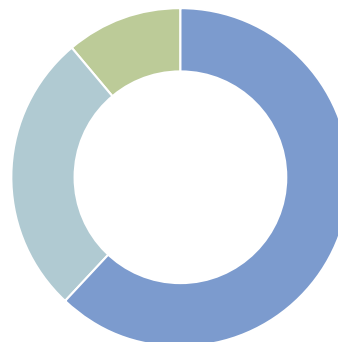

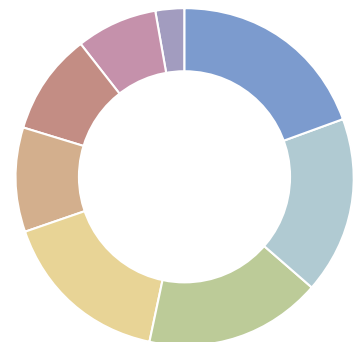
Geographic & Trend Distribution
