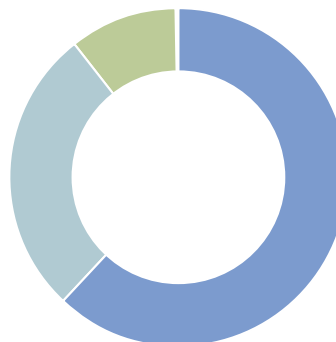

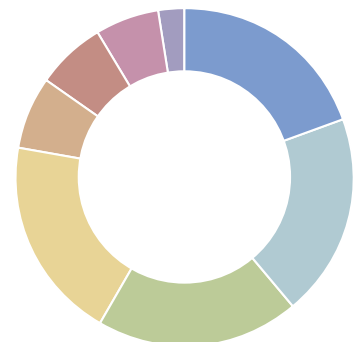
## Geographic & Trend Distribution
