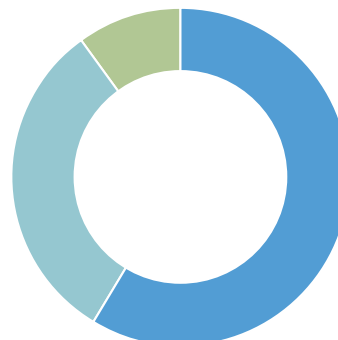

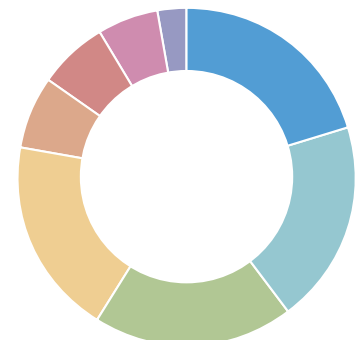
### Geographic & Trend Distribution
